MEMORANDUM OF UNDERSTANDING

This MEMORANDUM OF UNDERSTANDING (MoU) made and entered into on the date 15th February 2022 and SIGNED by the following parties:

- A. **Heritage Society, Patna (Bihar)**, expression of which shall mean and include its successors in interest and assigns of the first part (hereinafter referred to as HS), and
Add: Heritage Society, Phulwari Sharif, Patna, Bihar- 801505
- B. **Gulab Bai Yadav Smriti Shiksha Mahavidyalaya, Khargone (Madhya Pradesh)**, expression of which shall mean and include its successors in interest and assigns of the second part (hereinafter referred to as GBYSSM),
Add: Vidhya Vihar, Borawan, Khargone, Madhya Pradesh-451228

PREAMBLE

Heritage Society (HS) has been set up as an international standard organization for advanced studies in 2016 under the Society Registration Act, 21, 1860 with a mission to document, conserve, and promote tangible and intangible heritage through regular academic activities, publications, and by undertaking research in the field of education, culture and heritage studies alongside several innovative research, awareness and training programs.

Gulab Bai Yadav Smriti Shiksha Mahavidyalaya is a first premier NAAC accredited Teacher Training Institute in Nimar region of Madhya Pradesh. It was established under Gulab Bai Yadav Smriti Trust, Borawan in year 2002. D.El.Ed, B.Ed., M.Ed. and Doctor of Philosophy programs are run in the college. There is an IGNOU Study Centre of B.Ed. in the College. The Institute is approved by NCTE and affiliated to Devi Ahilya Vishwavidyalaya Indore, Madhya Pradesh. Gulab Bai Yadav Smriti Shiksha Mahavidyalaya (GBYSSM), is promoted by "Gulab Bai Yadav Smriti Shiksha, Mahavidyalaya Trust, Borawan" and was established under the dynamic leadership of its principal trustee Late Shri Subhash Yadav, Ex. Deputy Chief Minister, Government of Madhya Pradesh.

Both HS and GBYSSM have decided to enter into this MOU with a view of sharing a common interest to explore, extend and strengthen the functional relationship including Academics, Research Guidance, Extension and Training aimed at Educational Excellence as per their given respective mandate, aims and objectives in the following sections.

ARTICLE 1: PURPOSE and MODALITIES

In order to achieve the goal of inclusive education, it is necessary for HS and GBYSSM to act in convergent manner within the purview of their respective statutory provisions by sharing the academic resources and expertise available with both the parties, herewith HS and GBYSSM sign this Memorandum of Understanding (MoU) to cooperate and jointly work in the following general agreements:

1. Maximum and Sustainable use and utilization of available academic resources with both the parties, to conduct joint programmes of research, extension and training in such a synchronized manner that each of the party entering into agreement gets maximum advantage from their mandated objectives as well as for synergizing existing academic courses, research, extension and training programmes and schemes.
2. The faculty, officers, research staff of HS and its departments and GBYSSM of either party if needed, may take part in teaching, research, research guidance, extension and training activities in an academic session, as worked out and as per specialization and for the benefit of students, and faculties by mutual consultation.
3. Faculty, officers, Research staff of either/or both parties, may apply for joint collaborative research projects. Data generated and /or publications through such collaborative research could be published in joint authorship / joint copyright.
4. Undertaking Research Studies, Collaborative research programme, Study Exchange programme as per respective mandate and objectives of both parties would be taken up by the Faculty, officers, and Research staff.
5. Both the parties would cooperate and encourage sharing of experience, scientific knowledge, and technology advances, and its dissemination or expansion in communities/societies.
6. All research materials used in the collaboration will be transferred using Material Transfer Agreements (MTAs). Either party may use such materials, but will give due credit to the source of the materials.
7. HS will help GBYSSM in developing academic program in history and heritage studies for students of GBYSSM and will organize session, workshop, seminars, and mentoring sessions etc at regular intervals.
8. Infrastructure and local facility in the form of space, logistics and equipments to run theoretical and practical activities shall be provided by GBYSSM.
9. GBYSSM and HS will circulate our joint initiatives via respective official channels namely, notices, social media, press releases etc.
10. GBYSSM and HS will nominate/depute a responsible person as coordinator to ensure proper functioning of the unit setup to conduct the program covered under the MOU.

ARTICLE 2: COORDINATION

Each institution shall appoint one member of its teaching/research faculty to coordinate the programme on its behalf. Further, a coordination committee consisting of a programme coordinator from the side of HS, and a programme coordinator from the side of GBYSSM, will periodically review and identify ways to strengthen cooperation between the two institutions.

ARTICLE 3: DURATION, TERMINATION AND RENEWAL

1. This MOU will be initially effective for the period of **Five (05)** years from the date entering into it.
2. Notwithstanding anything contained in the MoU, the confidentiality and sociality of any research data or otherwise shall not supersede the Acts, Rules and by Laws of respective Institutions entering upon the MoU.
3. Either institute may terminate the MoU by giving written notice of three months in advance to the other institution. Once terminated, neither HS nor GBYSSM will be responsible for any losses, financial or otherwise, which the other institutions may suffer. However, HS and GBYSSM will ensure that the provisions of this Memorandum shall continue to apply to all activities in progress until their completion.
4. This MOU may be amended or modified by a written agreement signed by the representatives of both institutions.

ARTICLE 6: ADHERENCE TO LAWS

Participating faculties, staff and students involved in any activities under this memorandum must adhere to the law of the country and rules and regulations of the institutions.

ARTICLE 7: LEGAL EFFECT

Nothing in this Memorandum shall be construed as creating as creating any legal relationship between the institutes. This Memorandum is a statement of intent to foster genuine and mutually beneficial collaboration.

ARTICLE 8: DISPUTE RESOLUTION

In case of a dispute to any aspect of academic cooperation, Principal of GBYSSM and Director General of HS will jointly resolve the dispute in a spirit of independence, mutual respect and shared responsibility. HS and GBYSSM welcome the establishment of this Memorandum for cooperation and jointly agree to the provisions as set out above.
