




THIS AGREEMENT is made on this date 4th October.

#### BY AND BETWEEN

GULAB BAI YADAV SMRITI SHIKSHA MAHAVIDYALAYA, KHARGONE (MADHYA PRADESH), expression of which shall mean and include its successors in interest and assigns of the second part (hereinafter referred to as GBYSSM), Add: Vidhya Vihar, Borawan, Khargone, Madhya Pradesh-451228

Represented by its Head - PRINCIPAL (hereinafter referred as "Generator") as Party No. 1

#### AND

M /s. UNIQUE ECO RYCYCLE, INDORE (M.P.) having its registered office at Patwari Halka No.26, Survey No 332/2/9, Nemawar Road, PALDA, Indore-452020 (M.P.), represented by its Factory Head (hereinafter referred as "UER"/Collector) as Party No.2

The Generator and UER, hereinafter individually referred as 'Party' and collectively as 'Parties'. WHEREAS UER is engaged in business of E-waste management, as per guidelines under E-waste (Management) Rules, 2016.

WHEREAS THE Generator being desirous to the services of e-waste management as per guideline of e-waste (Management) Rules 2016 and UER accepted to provide such services on the terms and conditions set out in this Agreement.

NOW THEREFORE in consideration of the above-mentioned premises and the mutual promises contained herein, the Generator and UER have agreed to enter into this Agreement under the terms and conditions set forth hereinafter.

## NOW IT IS HEREBY AGREED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

## 1. DEFINITION AND INTERPRETATION

1.1 **Definition:** In this agreement, including in the recitals hereof, the following words, expressions and abbreviations shall have the following meanings, unless the context otherwise requires:

"Agreement" means this agreement including all attachments, annexure or schedules annexed thereto.



- "CPCB" means Central Pollution Control Board.
- "MPCB" means Madhya Pradesh Pollution Control Board.
- "SPCB" means State Pollution Control Board.
- "E-Waste Rules" means e-waste (Management) Rules, 2016 as amended from time to time.
- "Hazardous Rules" means Hazardous and other Wastes (Management & Transboundary Movement) Rules, 2016as amended from time to time.
- "E-waste" means 'e-waste' defined under the E-Waste Rules.
- 1.2 Interpretation: In this agreement, unless the subject or context otherwise requires:
  - A. references to recitals, clause and schedules / annexure are to recitals, clauses and schedules to this Agreement.
  - B. any reference herein to a statutory provision shall include such provision, as in force for the time being and as from time to time, amended or re-enacted in so far as such amendment or re-enactment is capable of applying to any transactions covered by this agreement.

### 2.0 Scope of Services:

- 2.1 The scope of services to be provided by UER under this agreement shall be collection, transportation, storage, dismantling, process and disposal of e-waste generated at the premises of the Generator located in the states of Madhya Pradesh, Maharashtra, Punjab and Haryana for the SPV's mentioned in the Annexure- II. ("Services")
- 2.2 UER shall dispose e-waste as per the mandate of the CPCB/SPCB read with the provisions of the E-Waste Rules.
- 2.3 UER also agrees to accept non-hazardous waste from Generator provided that the concerned SPCB has no objection.

#### 3.GENERAL CONDITIONS: -

(3.1) The duration of this Agreement contract shall be three years from date of execution and Services will be provided in four states i.e., Madhya Pradesh, Maharashtra, Punjab and Haryana Registration fees for four states shall be Rs. 50,000 + Applicable GST (Rs. 9000 considering 18%)

GST) = 59,000/- which is non-refundable. Registration shall be the responsibility of UER.

Or.S. Repaired payable by Generator and UER and other commercial terms are as mentioned in Gulab Bai Yadan Amirie Stukena.

(3.3) Generator should intimate UER by e-mail about 7-10 days in advance for collection of e-waste. Transportation of e-waste shall be the responsibility of Generator. UER will provide





transportation services on request from Generator, for which charges shall be paid by Generator as per Annexure-I.

- (3.4) Generator and UER shall follow all the norms of the E-Waste Rules, Hazardous Rules, applicable CPCB/SPCB guidelines as applicable to Generator and UER.
- (3.5) UER shall in its performance of this Agreement and carrying out of the Services comply with all applicable Law.
- (3.6) UER shall employ only suitably qualified, experienced, and licensed personnel to perform the Services in accordance with applicable Laws.
- (3.7) UER shall be liable for and shall fully indemnify and defend harmless the Generator from and against any and all claims, losses liability, action, demand, judgment, loss, damage, costs and expenses including attorney fees, in respect of:
  - (a) failure of UER or its sub-contractor to comply with the applicable laws, E-Waste Rules, Hazardous Rules, CPCB/SPCB guidelines etc.; and
  - (b) gross negligence or willful misconduct during performance/ non-performance of its obligations by UER or any of its subcontractor.
- (3.8) Neither party shall be responsible for any indirect or consequential damages and for any loss of revenue, loss of profit, loss of use, costs of capital or loss resulting to any other person or for any financial or economic loss, resulting from any reason attributable to the performance of this Agreement by either party.
- (3.9) Either Party shall have the right to terminate this Agreement in the event of violation of any of the terms and conditions of this Agreement, with immediate effect by written notice provided that where remediable, the Party has notified the other Party of such breach and the Party has upon receipt of such notice, failed to proceed and remedied such breach within 30 days from the receipt of written notice.
- (3.10) This agreement may be modified or amended only by writing, duly executed by or on behalf of the Parties hereto.
- (3.11) In the event that any provision of this agreement is held to be illegal, invalid or enforceable under any present or future laws of the Republic of India such provisions shall be deemed terminable, and the remaining parts & provisions of this agreement shall remain in full force & effect.
- (3.12) A party may notify the other Party of a change in its name and relevant address.
- (3.13) The Parties shall attempt to settle every dispute arising out of or in connection with this Agreement through mutual negotiation and discussion, failing which through arbitration as per the Indian Arbitration and Conciliation Act, 1996 and the rules framed thereunder for the time being in force, which rules are deemed to be incorporated by reference in this clause. The courts in





Mumbai, India shall have exclusive jurisdiction over all matters arising out of the arbitration agreement. The seat of arbitration shall be Mumbai. This Agreement shall be governed by and interpreted in accordance with laws of Republic of India and courts at Mumbai shall have exclusive jurisdiction over matters/ issues/ disputes arising out this Agreement. .14) Annexure-I & Hare integral part of agreement.
