Such programs may include any or all of the following activities:

- Encouragement of study by qualified students.
- Promotion of collaborative research in areas of mutual interest;
- Development of short-term training and extension programs
- Jointly organize and participate in meetings, seminars, and workshops;
- Any other areas which the parties agree and are in their mutual interest.

## ARTICLE 1:

### Terms and Conditions

- I. This MOU shall become effective from the date it is signed by the parties and shall be valid for five years. Both parties shall review the status of the MOU at the end of each five-year period to determine any modification, whenever necessary. The period of validity of this MOU may be extended by mutual consent up to five years. This MOU may be amended by mutual written agreement and The MoU can be terminated by either party by giving three months advance notice. from the effective date of termination.
- II. All joint activities not completed at the expiration or termination of the MOU may be continued until their completion under the terms of this MOU.
- III. No amendment or modification of the MOU shall be valid unless the same is made in writing by both the parties or their authorized representatives and specifically stating the same to be amendment of the MOU. The modifications/changes shall become part of the MOU and shall be effective from the date on which they are made / executed unless otherwise agreed
- IV. Since the first party is an NGO, there will be no financial burden on the first party.

## ARTICLE 2: Arbitration



If the dispute still remains unsettled, it will be referred for resolution bilaterally to Trustees. The decisions so arrived at shall be final and binding on the parties to this MoU
