The Objectives of the MOU are:

- b. Collaboration in Teaching, Research & Development and consultancy studied in the Field of mutual interest.
- c. The exchange of academic materials and publications. As per mutual benefit to be the course of both parties.
- d. Conducting lectures. As per mutual concerns. On both party premises.
- e. Attachments of staff for propose of curriculum development and review, upgrading of teaching research skills.
- f. Participating in seminars, symposiums workshop and other types of academic discussions as per the mutual concern.
- g. Conducting study tools and joint consultancy work.

OTHER AREAS:

- (1) To exchange information on research and educational programs.
- (2) To exchange information on teaching, learning material and other literature relevant to their educational and research programs.
- (3) To jointly organize short-term continuing education programs on topics of mutual interest and to invite each other's faculty to participate therein.
- (4) To organize jointly seminars conferences or workshop on topics of mutual interest and to invite each other's faculty and students to participate therein.
- (5) To exchange on a reciprocal basis, a student at Undergraduate, Graduate and Doctoral levels for limited periods of time for academic education and research, purposes.
- (6) To permit student, Staff and faculty members to use Lab, Library and other learning and research facility.
- (7) Sharing and updation of technical and academic knowledge.
- (8) Organize and participate in social outreach programmes for the benefit of society.
- (9) To work as a joint venture for students recruitment, campus placement, etc.
- (10) Promoting other academic cooperation mutually agreed.

Dr. C.V. Raman University and Department of Education Swa. Gulab Bai Yadav Smriti Shiksha Mahavidyalaya agree that detailed terms and conditions that guide each activity identified above will be determined separately and agreed upon by two institutions.

COORDINATION

Each institution shall appoint one member of its teaching faculty. To the programs on behalf of both parties further, a coordination committee consisting of a programs coordinator from the side of Dr. C. V. Raman University and a programme's from the side of that will be periodically reviewed and identify ways to strengthen cooperation between the two institutions.

CONFIDENTIAL INFORMATION

Department of Education, Dr. C. V. Raman University does not absolve any confidential information during the research activity.

VALIDITY

The Memorandum shall remain in form for a period of five years, commencing effective date. Institutions may extend the term by written agreement signed by both after review.

TERMINATION

Either institution may terminate the MOU by giving written notice of six months in advance to the other institution, once terminated neither of the institutions will be responsible for any losses, financial or otherwise, which the other institution may suffer. However, both the institution of this memorandum shall continue to apply to all activities in progress until their completion.

AMENDMENTS /MODIFICATIONS

The MOU by amended or modified by a written agreement signed by the representatives of both institutes.


